First Selectwoman Llodra and rest of the Board of Education,

Please see the email correspondence that was sent to Ms. Robinson 6 days ago and to Ms. Leidlein this past Monday, as of this moment, we have not heard back from either. Please note that that our inquiries re: the Super Bowl Trip and other misguided decisions are just beginning. As such, please explain to Ms. Robinson and Ms. Leidlein that their silence on this issue will not make it go away. We cannot understand how the Board could have approved an "anonymous donation" to Sandy Hook that did not explain to the public what the donation was nor, more importantly, its value. We have laid out some of the reasons for our outrage re: the trip below but just to reiterate, the fact that anyone in our town would think it was appropriate to send 20 children (and we say 20 because we obviously believe that the victims families should be given the opportunity) down to the Super Bowl when there are 20 families in our town who are grieving beyond what we can even imagine is outright insane. My son Matthew was in Ms. Wexlers class, directly across the hall from the carnage. He saw, heard and smelled things that no 7 year old should ever experience. He is traumatized on many levels but we do not consider him a victim. There were 20 babies massacred on Dec 14, they and their families are the victims. Did anyone reach out to these families to see what their opinion was re: this trip? I think not. It was a selfish and self serving decision. Next, let us point out the "value" of this donation. Many would argue that it is actually a priceless opportunity. However, we took the liberty to do some research and we found that the cost of a package such as this (Airfare, 5 days, 4 nights hotel, all food, tickets to the game, on field experience etc) would run anywhere from \$25K to \$30K PER PERSON. This would put the value of the "anonymous donation" at \$1,300,000 to \$1,560,000. Do the math and check the price of these packages yourself. This means that a \$1,250,000 (please note that we deducted \$250K for the victims families that deserve to be there) "anonymous donation" to the school was spent on 20 children in a district of how many students? OUTRAGEOUS. Again, our inquiries are just beginning and we would like you to shed any light that you can on this very important issue.

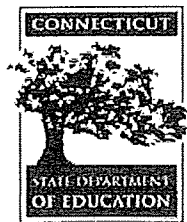

Some people worked at the warehouse, some people raised over a million dollars, some people hung snowflakes, some people hung bells, some people posted pictures on FB, and some people became politically active. We were all hurting but holding one another up and learning how to walk again each in our own way.

After the tragedy I spoke openly about what a blessing NYA was to our community. The NYA opened its doors to our community when we needed it most. The kids ran, the parents hugged, it was where our healing process began. We were weary and overwhelmed and during those dark days it was a place we could go. Through the tragedy and the days that followed a friend of mine followed my posts on FB. The world heard our cries and wanted to help. Tim Hayes was one of those people. Tim drove to Newtown to see for himself what the NYA was all about.

Tim Hayes began a project that he felt could bring our community together. Tim contacted Ingrid Michaelson and thus began the Sandy Hook Project. Tim's vision was to find a group of children who would sing the song Somewhere Over the Rainbow. The song had a message...the song was about staying together. It was a song of prayer.

Tim tried very hard to meet with Janet Robinson but was unsuccessful. This is understood. A lot was happening and this did not need to involve Newtown Public Schools. Tim wanted to explain the project and being an outsider really did not know where to go. Interestingly enough, Pat Llodra found time to sit down with Tim and hear the details of the project. The song was going to be released on iTunes and Amazon with the proceeds going to NYA and the United Way. The entire project was structured with lawyers involved, it was all done by the book.

Some time has now passed and those of you that know me know that I deal from my own deck. Yesterday Janet Robinson spoke with CNN condemning this project and saying these are not our kids. I find it interesting that Janet was never able to meet with Tim but now has the time to be conducting interviews with CNN. Sabrina Post was a former employee of NFS and there is controversy surrounding her involvement. This is where it becomes personal for me.

My daughter [redacted] was a part of this project. I knew full well that Sabrina Post had a history in Newtown that caused her both professional and personal humiliation. To be clear here, Sabrina has had absolutely no involvement with finances. The idea that the children involved in this project were exploited sickens me. Every parent who participated had full knowledge of the mission of the song. These were children that wanted to be a part of the healing process, these were children that wanted to help. If CNN were to interview 4 year old [redacted] she would say she was singing for Newtown. We have 26 angels that can no longer sing and this particular song honors them. [redacted] does not know what happened in her hometown but she knows something is very different. I am a mother first. I am a mother who needs her kids to be resilient. My kids understand my commitment to this town and leaving it better than I found it. My community had no choice on 12-14-12 but we do have choices on how we move forward. Our family felt this project valued something...the idea that we stand together. Whether it is on the football field, wrestling mat, the Super Bowl, or singing at MSG... we stand together. Questioning the integrity of this project involves me personally. I care deeply about this community and the ongoing support that will be required for years to come.
