

PRESIDENT TRUMP'S GLARING OMISSIONS

1. MEDICAL SCREENING OF ALL IMMIGRANTS

President Trump missed a golden opportunity to deal with ALL illegal immigrants by ordering strict adherence to Federal Code requiring proof of acceptable health or quarantining of foreign nationals entering the United States. Holding illegal immigrants in quarantine is one of the cover reasons given for construction of all the FEMA camps scattered around the United States. By issuing an Executive Order for strict enforcement of Federal Immigration Public Health Law he could have dealt more completely with the illegal immigration problem and avoided the current controversy, rioting, and all the court challenges produced by the partial solution of a temporary travel ban or suspension. It is not too late for him to issue such an executive order. Removing both would-be terrorists and disease carriers from the streets using Public Health Laws would be more effective than a travel ban.

In my February 9, 2015 commentary article "BLACK DAWN: BARACK OBAMA'S DREAMERS* BIOLOGICAL ATTACK ON AMERICA" (***Disease Redistribution Eliminating America's Mindless Eating Redundant Stooges**), I documented the scope and magnitude of diseases intentionally brought into the United States just from Central and South America to spread diseases here in the United States. Anyone entering the United States is required to either have medical proof that they are free of communicable diseases or be placed into quarantine until released by a Civil Physician who must be:

"A physician, with not less than 4 years' professional experience, selected by the District Director of INS to conduct medical examinations of aliens in the United States who are applying for adjustment of status to permanent residence or who are required by the INS to have a medical examination."

This required medical screening and quarantining is still not being done under the Trump Administration.

There is every reason to suspect that diseases spread by illegal immigrants have and will kill more Americans than actual terrorist attacks. It is currently not possible to even examine this issue because either no one is doing the necessary epidemiological investigations or, if they are being done, the results are not being made public.

Perhaps President Trump might benefit from covert consulting with an expert in reverse engineering malevolent enterprises. Maybe a white ops (as opposed to black ops) specialist who compiled a Congressional Evidence Book on organized crime and organized science fraud integrated into the United States child protection, mental health, and social work systems.
